Portugal offers outstanding landscape diversity, due to its North-South disposition along the western shore of the Iberian peninsula. You can travel in a single day from green mountains in the North, covered with vines and all varieties of trees to rocky mountains, with spectacular slopes and falls, to a near-desert landscape in the Alentejo region and finally to the glamorous beach holidays destination Algarve. If you hunger to experience the splendor of European landscapes, culture and way of life, Portugal will satisfy your desires.

## ITINERARY

### **Day 1: Monday December 21 Departure from the USA to Portugal.**

### **Day 2: Tuesday December 22 Welcome to Lisbon!**

Upon arrival, proceed through customs and collect your luggage. **One group transfer for flight arriving 9:30 a.m** Our local professional guide Maria will personally meet and greet you. Departure for a Panoramic tour of Lisbon by deluxe coach before drop off at the hotel. Check in and orientation tour around the hotel with our guide followed by some free time for lunch while the rooms are getting ready. Rest of the day at leisure. Tonight, enjoy a welcome dinner with the other group members in a local restaurant nearby the hotel escorted by our guide. Overnight in Lisbon. **(Dinner)**

### **Day 3: Wednesday December 23 Sintra and Cascais Coast**

Breakfast at the hotel. Today, depart on a full day trip and feast your senses on the splendid scenery of Sintra, a UNESCO listed village. Alongside your guide, you'll witness the fairy-tale beauty of the Pena Palace. Considered the greatest example of 19th-century Romanticism in the world, the palace sprawls on a hilltop high above Sintra, and can often be seen from Lisbon, 17 miles away. Tour the Pena Palace of Sintra, a palace shrouded in a thousand years' worth of history.

Continue to Sintra and free time for Lunch and shopping in this quaint little village.

In the afternoon, follow your guide on a tour of the coastal village of Colares. Then return to your coach and admire views of the Portuguese countryside as you travel to Cabo da Roca: Europe's westernmost point. Gaze at the crashing waves of the Atlantic Ocean before returning to your coach and travelling to Hell's Mouth cliff (Boca do Inferno) a dramatic collection of caves carved by the vigorous waves of the Atlantic. Resume the drive along the picturesque Estoril Coast and enjoy panoramic views of the Casino Estoril, one of Europe's biggest casinos, believed to be where Ian Fleming (the author of the James Bond series) developed the idea for Casino Royale. Quick stop in Cascais Bay time permitting. After your tour, admire the beautiful Portuguese countryside on your way back to your hotel in Lisbon. Overnight in Lisbon. **(Breakfast)**

### **Day 4: Thursday December 24 Full Day tour of Lisbon**

After breakfast, meet your guide at the hotel and set off for your guided tour of Portugal's hilly capital. Board a coach and head to Lisbon's riverside district of Belém and see two UNESCO World Heritage-listed monuments. First, visit the 16th-century Jeronimos Monastery and listen as your guide explains how the ornate arches and abundance of pinnacles is a prime example of Portuguese Manueline-style architecture. Nearby, see the Belém Tower, where soldiers once gazed over the Tagus River searching for incoming invaders. Continue to the Monument to the Discoveries which honors Portugal's Age of Discoveries and its navigators who left to explore trade opportunities with India and the Orient.

Free time for lunch in Lisbon.

Afterward, stretch your legs with a walking tour through Lisbon's historic center. See some of the traditional neighborhoods like Castelo, Mouraria, and Alfama, the city's oldest district. Learn about the influence of the Moors in this 8th-century neighborhood and then meander around narrow streets up to Graça viewpoint, where you can take in One Of the best bird's eye views of Lisbon. Your tour will conclude with drop-off at the hotel.

Tonight, enjoy a nice Christmas Eve dinner in Lisbon. Overnight in Lisbon. **(Breakfast, Dinner)**

### **Day 5: Friday December 25 Lisbon**

Breakfast at hotel. At 8:30AM we depart for Porto with a stop in the famous religious site of Fatima for a short-guided tour. After our visit of Fatima, continue on to Nazare for Lunch at Pangeia Restaurant or similar. Following lunch, we continue on to Porto. Overnight in Porto. **(Breakfast, Lunch)**

### **Day 6: Saturday December 26 Porto – Morning tour and afternoon to enjoy the city**

Breakfast at the hotel. After a breakfast, Departure by coach for Porto, the second largest city in Portugal, stands out from the steep banks of the Douro river with its mixture of grey facades and red tiles interspersed with unusual architectural masterpieces. Its historical center was listed as a World Heritage Site by UNESCO in 1996. We'll cross the Dom Luis I Bridge again back to Villa Nova de Gaia for the visit of a wine cellar follow by lunch. Porto's pride notably stems from its famous wine known the world over, which you will get to taste. Afternoon free to enjoy the city. Overnight in Porto. **(Breakfast, Lunch)**

### **Day 7: Sunday December 27 Porto: Day at leisure.**

Breakfast at hotel. Optional visit: Priority entrance ticket to visit the famous Bookstore Lello. The World's most beautiful bookshop present in Porto since 1906. Today, it carries more than a century of heritage with its architecture and bookselling knowledge that take part in the visitors experience visiting Lello Bookstore . Overnight in Porto. **(Breakfast)**

### **Day 8: Monday December 28: Departure day.**

Breakfast at the hotel and free time to browse the city of Porto before departure to the airport from the hotel with an assistant from our staff. **One group transfer at 12:00 pm** End of our services **(Breakfast)**

**Cancellation Policies:** No charges other than the non-refundable initial service fee/deposit are levied for individual passengers canceling up to 91 days prior to the commencement of Jet Vacations LLC services. If a passenger cancellation creates a change in the price schedule, the tour price will be revised based on the remaining number of participants. A passenger becoming a single as a result of a partner's cancellation must pay the single supplement.
